- 1) Overtime is paid using the Taxable Wage (Taxable Wage X Overtime Rate) then the taxable deductions (Dues and Vacation) are deducted.
- 2) Training Contributions are based on 1.78% of the Group 1 Journeyman Carpenter gross wage (Taxable + Fringe).
- 3) Fringe Benefits are to be paid on all hours worked (with the exception of Pension for 1st and 2nd term Carpenter Apprentices -Article 27) in addition to the taxable wage rate.
- 4) Apprentices in the 1st and 2nd periods, when working on any State or Federal Prevailing wage projects shall have their Pension Fund contributions paid in full at the managing trust.
